GLOSSARY:

1S : 1^{er} semestre (1st semester)

2S : 2^{ème} semestre (2nd semester)

SPE : Cours magistral spécialisé (*specialized amphitheatre lecture*)

MAG : Cours magistral fondamental

The *cours magistral*, or lecture is a conventional type of teaching given in a lecture hall or classroom. Lecture courses are semester courses and add up to 24 hours of tuition.

CONF : conférence de méthode

The *conférence de méthode* (practical seminar/discussion group) is a practical and interactive teaching method involving groups of about twenty students at a time. Its aim is to help students develop a sound method of working and to enable teachers to check the efforts and progress made by them throughout the semester. It comprises a wide variety of exercises, such as oral exposés, oral and written tests, discussions and debates, bibliographical research, the construction of arguments, plans, notes, written compositions, and investigations. This work may be carried out individually or as in teams. The *conférence de méthode* is organised on a semester basis and adds up to between 18 and 24 hours of tuition.

SEM : Séminaire (*seminars*)

The *séminaire* (seminar course) is a teaching module reserved for fourth year students only, aimed at guiding students towards the production of a sixty-page dissertation. It incorporates sessions during which students' papers are presented and discussed, guidance sessions, and conferences given by specialists, researchers and professionals in connection with the theme of the seminar. It also involves personalised supervision of the dissertation by the seminar supervisor. Seminar teaching lasts all year round and adds up to a total of 48 hours.
